At the August 16, 2018 meeting of the Physcial Properties Committee, the Committee reviewed proposals to paint the Medical building (colors as approved by the Architectural Design and Review Committee) as follows:

Hutton Painting

\$14,500

CertaPro Painters

\$15,750

Staff recommends using Hutton painting, at a cost of \$14,500 adding a contingency of \$2,000, for a total cost not to exceed \$16,500, pending review by the Finance Committee for funding.

At the August 20, 2018 meeting of the Finance Committee, the Committee determined enough Capital funds are available for the proposed project.

I move to approve the exterior painting of Trust Property identified as the Medical Center, in the amount not to exceed \$16,500 (\$14,500 Hutton Painting and \$2,000 for unforseen contingencies), Capital Funding, and authorize the President to sign the contract with Hutton Painting and futher authorize the Chair of the Physcial Properties Committee to approve any use of contingency funds.

Back Rolling: This application involves spraying the surface with one heavy coat of material immediately followed by rolling the surface with a heavy nap roller. The material is forced into the voids and cracks of the surface for the best possible material penetration. Back rolling is the best method of application for weathered areas of the trim and siding, as well as the garage doors.

Scope of Work: The preparation and painting of the exterior portions of the Leisure World Medical Building in accordance with the Vista Paint Specification dated May 21, 2018.

Products: Vista Paint fine quality paint products in accordance with the Vista Paint Specification dated May 21, 2018.
