MINUTES

The regular monthly Council meeting minutes of October 4, 2018 were approved by general consent of the Council as printed.

GUEST SPEAKER - Mr. Massetti

Mr. Massetti gave presentation to the Council regarding Purple Air and air quality control.

FACILITIES DIRECTOR

Mr. Weaver discussed the water conservation ordinance. He reminded the Council that the city will allow for watering days for all the Mutuals as follows:

All Mutuals: NO WATERING Wednesday night / Thursday Morning

All watering shall take place between the hours of 5:00 p.m. and 9:00 a.m. No water shall be used to wash down sidewalks or driveways.

Mr. Weaver also discussed the California Code of Regulations regarding pesticide applications. This subsection applies to the use of any pesticide for purposes other than the commercial or research production of an agricultural plant commodity. Notifications required by this subsection must be given orally or in writing and be completed prior to the use of any pesticide and in ample time for all subsequent notifications to be made and for all persons notified to take appropriate action. This time will differ depending on the circumstances of each notification.

MUTUAL ADMINISTRATION DIRECTOR

Ms. Hopkins presented her report.

EXECUTIVE DIRECTOR

Mr. Ankeny stated that the primary inspection for the CAMUTCD has been completed and certification should be received before the end of the year. In preparation for the Seal Beach Police Departments presence in Leisure World there will be two Town Halls scheduled to inform residents and shareholders of what will take place upon completion of this project.

Mr. Ankeny also stated that notice has not been received yet for the repairs of the elevator in the Administration Building. Once notice is received the elevator will be offline for 3-4 weeks, and all Mutual Boards will have enough notice before the project is set to begin.

Mr. Ankeny thanked all the Mutual Boards for approving the extension of telecommunications with Superwire and this item will be forwarded to the GRF Board.
