At its June 9, 2020 meeting the Golden Rain Board of Directors approved Fitness Center Expansion, Phase 1 (Physical Changes and Interior Finishes). Phase 2 of the project is now being brought forth to the Board for the replacement and addition of the Fitness Centers equipment under the direction of a professional fitness consultant with equipment under full manufacturer's warranty and maintenance and inspection programs. The replacement of the equipment has been recognized by our insurance broker as:

"...As you are aware, Phly values Leisure World Seal Beach and its Boards proven and trusted professionalism in making improvements that continue to make Leisure World Seal Beach a safer place.

The proposed fitness center under the direction of a professional consultant and proposed replacement of the fitness equipment is another example of the many proactive measures the community continues to take in seeing Leisure World Seal Beach continues to be the most safe community in the nation.

As we have discussed, we are in a very challenging/hard insurance market with all policies under significant scrutiny!

This is a very important change and another example of the type improvements which have enabled Phly to continue to provide the absolute best policy renewal terms, conditions and lowest premiums possible..."

Three companies were solicited to provide quotes on the equipment list that was approved by the Fitness Equipment Review Committee members, bids were as follows (see Exhibits). The new equipment will provide the Fitness Center with updated and technologically advanced equipment fitting the unique and varied needs of the community membership.

1. Out- Fit	\$323,740.54
2. Precor Commercial Fitness	\$327,105.43
3. Commercial Fitness Equipment	\$341,209.65

All quotes include tax, shipping, and setup fees. Also included will be an equipment warranty and a service agreement.

Reserve Funding (replacement of existing equipment) of \$286,698.95 and Capital funding (additional equipment) of \$32,925.65 is requested (see Exhibits).

I move to approve the acceleration of Reserve funding, in the amount of \$286,699, and authorize Capital Funding, in the amount of \$37,042, for a total funding authorization of \$323,741 and authorize the Executive Director to initiate the purchase of fitness equipment, from Out-Fit fitness company, in the amount of \$323,740.54.

# THE FACTS



Physical Activity and Health: A Report of the Surgeon General

### Facts

- •The loss of strength and stamina attributed to aging is in part caused by reduced physical activity.
- Inactivity increases with age. By age 75, about one in three men and one in two women engage in no physical activity.
- •Social support from family and friends has been consistently and positively related to regular physical activity.

### **Benefits of Physical Activity**

- •Helps maintain the ability to live independently and reduces the risk of falling and fracturing bones.
- •Reduces the risk of dying from coronary heart disease and of developing high blood pressure, colon cancer, and diabetes.
- •Can help reduce blood pressure in some people with hypertension.
- •Helps people with chronic, disabling conditions improve their stamina and muscle strength.
- •Reduces symptoms of anxiety and depression and fosters improvements in mood and feelings of well-being.
- •Helps maintain healthy bones, muscles, and joints.
- •Helps control joint swelling and pain associated with arthritis.

### **Key Messages**

•Older adults can benefit from regular physical activity. •Physical activity need not be strenuous to achieve health benefits. •Older adults can obtain significant health benefits with a moderate amount of physical activity, preferably daily. A moderate amount of activity can be obtained in longer sessions of moderately intense activities (such as walking) or in shorter sessions of more vigorous activities (such as fast walking or stairwalking). •Additional health benefits can be gained through greater amounts of physical activity, either by increasing the duration, intensity, or frequency. Because risk of injury increases at high levels of physical activity, care should be taken not to engage in excessive amounts of activity. •Previously sedentary older adults who begin physical activity programs should start with short intervals of moderate physical activity (5-10 minutes) and gradually build up to the desired amount. •In addition to cardiorespiratory endurance (aerobic) activity, older adults can benefit from muscle-strengthening activities. Stronger muscles help reduce the risk of falling and improve the ability to perform the routine tasks of daily life





## What Communities Can Do

•Provide community-based physical activity programs that offer aerobic, strengthening, and flexibility components specifically designed for older adults.


- •Ensure that facilities for physical activity accommodate and encourage participation by older adults.
- •Provide transportation for older adults to parks or facilities that provide physical activity programs.
- •Encourage health care providers to talk routinely to their older adult patients about incorporating physical activity into their lives.
- •Plan community activities that include opportunities for older adults to be physically active.



## THE SOLUTION

Leisure World Seal Beach has already taken a major step towards promoting health and wellness within their community. Although the current gym offers a great mix of equipment to accommodate the needs of all the residents there are some additional components that can be addressed to ensure that the majority of the community have access to everything they need within the fitness facility to stay healthy and active.

After touring the facility we have determined a few key area of improvements that can be made to create a health club and environment that will attract the most members within the Leisure World community. As a result, a number of additional benefits can be achieved as a "return of investment" into the current gym refresh including but not limited to longer life expectancies, healthier living, and increased property values.



# Leisure World Current Gym Equipment Issues:

### Age of Equipment

PROBLEM: The majority of equipment is at least six years old. Once equipment reaches the end of its "lifespan" equipment costs soon outweight the purchase of new equipment under warranty. In addition, liability risks go up with older equipment.

SOLUTION: Trade out old equipment with new state-of-the-art equipment with full warranties

## Additional Equipment Needs

PROBLEM: Although the aging population uses a majority of the same equipment as your typical gym-goer there are some speciality pieces that are specific to the retirement communities.

SOLUTION: Purchase new equipment to supplement the equipment already offered to increase usage within the community.

## Equipment Flow/Size of Space

PROBLEM: The current gym does not have the best flow. Walkways are not clearly defined in terms of ADA compliance and there are no specific areas for the different types of equipment and exercises.

SOLUTION: Redefine spaces within the gym and create a better flow using the new equipment that is more visually appealing.

# Why Purchase New Equipment.

Fitness centers, in general, follow a fairly standard blueprint when it comes to updating/replacing equipment. Big gyms struggle to attract and maintain clientele so they must always offer the newest and best equipment in a wide selection. In a facility such as the Leisure World gym there are other variables to consider when faced with the decision of when to replace outdated equipment. Some are straight forward such as:

- New equipment provides a clean look and creates a new, fresh, motivating atmosphere
- New equipment often incorporates the latest in biomechanics, safety, and technology
- New equipment can reduce risk of injury often seen in older equipment
- New equipment can follow current trends or offer a new type of workout to the facilities members.

When we consult on a project we break the fitness center down into three equipment categories – (cardiovascular equipment, strength equipment, and freeweight equipment) and create basic recommendations within these categories.


### Leisure World Fitness Center Recommendations:

**Cardiovascular Equipment:** Replace all cardiovascular equipment. All equipment is well past the warranty period and shows signs of wear. It is not uncommon for repairs to run up to \$1000 (belt/deck/electronics). Equipment looks dated as well. We also recommend adding a few additional pieces after determining member usage and getting feedback from the front desk staff on high-use pieces.

**Strength Equipment:** Strength equipment is well past warranty and showing signs of wear. Liability risks go up with outdated strength equipment due to potential of failure. Also, there are currently a number of different lines of strength. Changing out will decrease liability risk and provide a much more uniform appealing look. In addition to changing out pieces we are recommending adding a line made specifically for the elderly population which is much less intimidating and more user-friendly. This line can be used individually or in a circuit class setting.

**Freeweight Equipment:** Current freeweight are a mix of many different types but all showing signs of excessive wear. Dumbbells are rusted and flaking and the benches are chipped. We recommend replacing with new racks and urethane dumbbells which are quiet and do not chip the equipment. Benches and freeweight equipment will be updated and will all have a uniform look. In addition, we are recommending adding more functional pieces for a dedicated area.





The Golden Rain Foundation, Seal Beach ("Seller"), for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, does hereby bargain, sell, quitclaim, transfer, deliver, and convey, all without representation or warranty, to <u>name (</u>"Buyer"), all of Seller's right, title, and interest in and to the following used personal property (the "Property") located as of the date hereof "AS-IS", "WHERE IS" and "WITH ALL FAULTS":

Buyer and Seller acknowledge as follows:

THE PROPERTY TRANSFERRED HEREIN IS IN USED CONDITION AND IS TRANSFERRED "AS IS" AND "WHERE IS". SELLER MAKES NO EXPRESS OR IMPLIED WARRANTIES OR REPRESENTATIONS OF ANY KIND WHATSOEVER IN REGARD TO THE EQUIPMENT. SELLER HEREBY DISCLAIMS ANY AND ALL REPRESENTATIONS AND WARRANTIES IN REGARD TO THE PROPERTY, INCLUDING, WITHOUT LIMITATION, THOSE OF MERCHANTABILITY, FITNESS FOR USE OR FITNESS FOR ANY PARTICULAR USE, OR OF QUALITY, DESIGN, CONDITION, CAPACITY, SUITABILITY OF PERFORMANCE.

Buyer represents and warrants that it has fully examined and inspected the Property, and has not relied and is not relying upon Seller to assist it in any way in such examination or inspection, or in the operation, maintenance, service or repair of the Property, nor shall Seller provide any assistance with delivery and set up of the Property.

#### **Disposition of Surplus Equipment**



All surplus property and equipment which has come to the end of its useful life to the community is to be disposed of in such a manner as to yield a maximum financial return to the Golden Rain Foundation (GRF). Foundation/Mutual surplus equipment may not be sold, traded-in, salvaged, scrapped, donated or otherwise disposed of without prior approval from the Finance Committee and will be executed at the lowest possible cost. In keeping with this policy, the following steps will be considered due diligence for disposal of surplus property:

#### 1. INITIATION OF DISPOSAL PROCESS:

When a Mutual or GRF department seeks to declare property as surplus, the Purchasing Manager will be advised of intent to transfer surplus property to the warehouse for the removal process via Equipment Transfer/Disposition of Equipment form sent via email. In turn, the Purchasing Manager will then initiate and execute the steps outlined below for removal.

#### 2. DISPOSAL BY INTERNAL TRANSFER:

For GRF properties priority will be given to internal re-circulation of properties in an attempt to repurpose surplus items. The Purchasing Manager will communicate via email to department heads notification of property available on a first come, first serve basis. If there is no call for repurposing, the Purchasing Manager will present a list of the items received as surplus, along with an assessment of fair market value, to the Finance Committee for review and approval.

#### 3. DISPOSAL BY SALE TO SHAREHOLDERS:

GRF and Mutual property deemed to have a resale value, will be sold on a first come, first serve basis at the approved set price or open for best offer. Items will be sold "as is" for pickup. Notification of items for sale will be done through the classified section of the LW Weekly for the period of at least one week. Mutual items that cannot be sold internally will be reported back to the mutual contact for further disposition. If no further disposition is received from the Mutual contact after seven (7) days items will continue through the following steps with any remaining GRF items.

#### 4. DISPOSAL BY DONATION:

GRF Items that cannot be sold internally may be donated to nonprofit organizations.

#### 5. DISPOSAL AS WASTE:

GRF Items that cannot be sold or donated will be discarded through the GRF's normal scrap, recycle or waste removal process.

#### 6. FINAL REPORTING:

Final disposition of all disposed items will be reported back to the Finance Committee by the Purchasing Manager. Mutuals will be credited for items sold on their behalf, where appropriate.
