# **GUEST SPEAKER(S)**

Mr. Michael Perry and Ms. Jill Chavez with DLD Insurance presented their Leisure World of Seal Beach – Commercial Insurance Structure as of January 2021 graph. The insurance representatives discussed the coverages for the Golden Rain Foundation and Mutual combined, solely the Mutuals, and solely the Golden Rain Foundation. They mentioned the policy had pandemic exclusions, i.e., formidable diseases. Congress right now is reviewing a pandemic risk type insurance for the near future. According to Mr. Perry, the cost is 2.5 million combined for the year.
