At this time, the Committee determined there are no liquid funds to invest at this time.

i. Capital Funds Investment Purchase

Ms. Isom MOTIONED, seconded by Mr. Friedman and carried unanimously by the Committee members present—

TO recommend the GRF Board authorize the purchase of brokered CDs through US Bancorp totaling \$300,000 of capital funds, with terms ranging from six (6) to eighteen (18) months at the prevailing interest rates at the time of purchase and at the discretion of the financial advisor.

i. Two Picnic Tables and Two Trash Can for Clubhouse One Picnic area

i. Administration Building Office Improvement

TO inform the Board that the Finance Committee has determined Reserve funds, not to exceed \$48,285, are available and have directed the Director of Finance to place a temporary hold on these funds, pending Board action for the modifications at Stock Transfer and Administration, in the amount not to exceed \$48,285, Reserve Funding.

SRO Labor Rates

TO increase the SRO labor rate from \$47.20 to \$50.00 for straight time and from \$70.80 to \$75.00 for overtime, effective January 1, 2023.
