Project	Status
Phone System	Finalizing the programming for SIP trunking. Submitted the e911 information for the phone numbers, looking to end of august, 1st week of September for the hardware install in the server room. It will be another 2 weeks or so for the network configuration once the phone system is here; roll out the phone system to the users by swapping out their phones.
Cinc System	The Architectural module (Permits) & Work Order Module (Service Maintennace Request) are going live next. Fenn Work Order's Live 9/1- to test module before implementing inventory and all other work orders.
Clubhouse Four Dais	Project Completed- August 2023
Document Scanning	Hired temp. staff to complete this project
Gate Access	Working on CG systems to get the controllers connected to Proptia and should have that done by next week (Update as of 8/23/23)
Website Implementation	IT staff to complete this project HOA Sites has been signed up; working on migrating data. Slating 3 weeks to get the data migrated, after the data is migrated, review data and run testing.
GRF Surveilance Cameras	Estamate \$50k. Currently going through all 138 cameras and are working on getting them back up and running. Will replace most if not all of the cameras, as they are older, lower resolution cameras and are not supported. Recovered about 12 cameras from a down state so far.
Livestream Tech Issues	Replaced the computer in Conf A; replacing the Conf B computer next week. Installing a table top monitor in Conf B, to mirror Conf A; Hardware arrives next week on the 7th, however, cabling will be needed to run the monitor, and that most likely will be completed by next Friday.
Board of Directors Tech Training	September 12th, 2023 in Learning Center- Time TBD
Homewise Docs	Web-based service has launched, and training has been conducted for both staff and escrow companies. The internal process is running smoothly. Revenue through the homewise docs system is \$40,398.00 as of 8/24/2023.
